1.Users Obligations

The user is solely responsible for disconnecting and deleting all of access to the Information and Personal Website data from any browser, pc or any other equipment, through which he visits the website, is registered in the electronic services and is connected each time.

2. Intellectual Property Rights

The entire content of the website, except for the expressly stated exceptions (copyright of third parties), which - indicatively - includes texts, graphics, images, photos, drawings, videos, sounds, etc. (hereinafter the content), constitutes intellectual property and service marks of equal society and is protected by the applicable national, Community and international law.

3. Protection of Personal Data

Our website is in compliance with the provisions of the GDPR 679/2016 and the relevant laws Greek Law 4624/2019.

The administration and protection of the personal data of the visitor/user is subject to these terms as well as the provisions of national, Community and international law on protection of the individual from the processing of personal data, as they are in force.

Any future relevant regulations will become the subject matter of these rules. In any case our website reserves the right to change the terms of protection of personal data in the context of the relevant legal framework in force from time to time. The website uses the personal data of the users, given that they have been registered through the contact form section of the website and provided their consent, in order for the website to contact him or because of his registration in the newsletter. You may withdraw your consent at any time.
